

ORDER OF CONSOLIDATION.

THIS MATTER coming on to be heard at a meeting of the undersigned Board of County Commissioners held at the office of the said Board in Kelso, Washington, on the 13th day of October, 1923, at 2 o'clock in the afternoon of the said day, said meeting being held pursuant to a resolution and order duly passed and entered by said B oard on the 12th day of September, 1923, whereby said County Commissioners declared their intention to order the consolidation of the above entitled diking improvement districts, and fixed the time and place above mentioned for hearing objections to such consolidation, and it appearing to the satisfaction of said Board of County Commissioners that due and lawful notice of the said hearing and of the time and place for holding the same has been given by publication once a week for two successive weeks in the newspaper doing the County printing of Cowlitz County, to-wit: "The Kelsonian", a newspaper published in Kelso, Cowlitz County, Washington, and that the last publication thereof was not less than seven or more than fourteen days prior to the date of said hearing, and further that said notice was posted for the same period in three public places in each of the districts proposed to be consolidated,

And the said Board of County Commissioners having at said

hearing heard and considered all objections to the proposed consolidation then and there offered, and all evidence relating thereto, and having duly considered the matter, and it appearing to the satisfaction of said County Commissioners that the consolidation of said diking improvement districts into one consolidated district will result in economy of the maintenance of such districts and that the best interests of the public and of the owners of lands within said districts will be subserved by such consolidation.

Cowlitz County, Washington, Diking Improvement District No. 4 of Cowlitz County, Washington, Diking Improvement District No. 7 of Cowlitz County, Washington, Diking Improvement District No. 8 of Cowlitz County, Washington, Diking Improvement District No. 8 of Cowlitz County, Washington, and Diking Improvement District No. 10 of Cowlitz County, Washington, be and they are hereby consolidated, and that the territory included in such Districts shall from and after this date constitute and be known as "Consolidated Diking Improvement District No. 1 of Cowlitz County."
